The Bid Security shall be in the form of Demand Draft /RTGS/NEFT/BG from any Nationalized Bank drawn in favour of "Nabha Power Limited" payable at Rajpura and shall be submitted to the office of "Head Procurement, Nabha Power Limited, Near Village Nalash, Rajpura, Punjab-140401" up to schedule date and time, as above.
